

SUMMARY ANNUAL REPORT

For the ANDEAVOR OMNIBUS GROUP WELFARE BENEFITS PLAN

This is a summary of the annual report of the ANDEAVOR OMNIBUS GROUP WELFARE BENEFITS PLAN, EIN 38-4084986, Plan No. 501, for period 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Andeavor LLC has committed itself to pay certain self-funded Medical, Dental, and Severance claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Blue Cross Blue Shield of North Dakota, Deer Oaks EAP Services LLC, Hyatt Legal Plans Inc., Kaiser Foundation Health Plan Inc, Liberty Life Assurance Company of Boston, Life Insurance Company of North America, Metropolitan Life Insurance Company, and Vision Service Plan to pay Medical, Prescription, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$34,793,670.

Some of the above contracts are called "experience-rated" contracts, whose premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2018, the premiums paid under such "experience-rated" contracts were \$6,450,783 and the total of all benefit claims paid under these contracts during the plan year was \$6,426,253.
