# Where to get breast pumps

The preventive care provision of the Affordable Care Act (ACA or health care reform law) states that health plans must cover one breast pump per pregnancy with no cost sharing for female members. This applies to nongrandfathered plans with renewals starting on or after August 1, 2012.

Members can buy or rent breast pumps from any hospital, doctor or durable medical equipment (DME) company that are in-network. However, some local in-network doctors and DME companies may not carry breast pumps. ### Key points

- Only female members are eligible for this benefit.
- Only one breast pump is covered at no cost share per pregnancy.
- Generally, hospital grade breast pumps are rented instead of bought.
  - Members may need a prescription for a hospital grade pump when renting from an in-network DME company.
- Retail stores such as Meijer, Target or Babies "R" Us ® are not DME companies, so breast pumps bought from these types of stores are not covered.
- This benefit is not a pharmacy benefit. Breast pumps are not covered when bought from any pharmacy, regardless if in-network or out-of-network.
