

SUMMARY ANNUAL REPORT

For ANDEAVOR SHORT-TERM DISABILITY PLAN FOR SPECIFIED EMPLOYEES

This is a summary of the annual report of the Andeavor Short-Term Disability Plan for Specified Employees, EIN 31-1537655, Plan No. 522, for period 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,025,692 as of 12/31/2020, compared to \$2,244,696 as of 01/01/2020. During the plan year the plan experienced a decrease in its net assets of \$-1,219,004. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$3,972,331 including employer contributions of \$3,966,496 and earnings from investments of \$5,835.

Plan expenses were \$5,191,335. These expenses included \$51,859 in administrative expenses, and \$5,139,476 in benefits paid to participants and beneficiaries.
